- Authorized Mini Mania Installer** - Purchase a minimum of \$5,000.00 of product inventory to initiate the account upon approval of application. There is no annual minimum purchase to maintain under this designation. All products purchased will receive a 13% discount (0% for Low Margin items).

- Authorized Mini Mania Reseller** - Purchase a minimum of \$1,000.00 of product inventory to initiate the account upon approval of application. There is no annual minimum purchase to maintain under this designation. All products purchased will receive an 8% discount (0% for Low Margin).

2. That I (we) make sure that above terms are complied with and I (we) will notify you immediately of any changes of the above facts;

5. That all invoices will be paid within the terms indicated to prevent termination of credit.

DEFAULTS: In the event of default for non-payment, purchaser agrees to pay all costs incident to collection, including but not limited to reasonable attorney's fees, cost of collection and court costs. This contract is made in the State of California. The buyer, by placing an order, agrees to submit to the jurisdiction of the courts of the State of California, County of Nevada, and that the laws of the State of California shall apply.
